Public Forum

Motion and roll call vote to recess Planning and Zoning Meeting session and to go into Public Forum Consideration of Bubbas Buds LLC. application for a Special Use Permit for Cannabis Manufacturing Legal description UPC 1009027447400000000. 2295 HIGHWAY 304 Rio Communities, NM 87002

Motion made by Commissioner Winters to recess the Planning and Zoning meeting session and go into a public forum Bubbas Buds LLC. application for a special use permit for cannabis manufacturing. Chris Clifton explained they would be doing ethanol extractions. By taking flowers and converting it into oil and making vape carts out of it. He explained they have all their state licenses, and they are trained by the state.

Commission Winters asked about the pressurized system.

Chris Clifton explained that it is all contained for cross contamination and to prevent fire and Valencia County has used their facility for training.

Commissioner Winter asked about the noise.

Chirs Clifton explained it is a quiet process.

Commissioner Winters asked about the traffic.

Chris Clifton explained that they would only have two employees and maybe two vehicles for pick up a week.

Commissioner Henderson asked about waste.

Chris Clifton explained that they follow state regulations.

Dick Irvin stated that he had a survey on next door and there weren't very good reviews.

Ralph Mimms asked how big his facility is.

Chirs Clifton stated about 7,500 square feet.

Chair Good talked about the comprehensive plan that the Commission had spent awhile working on with changes that were made. Chair Good requested to have a community discussion on some areas of the comprehensive plan.

There was a discussion.

Billy Baca explained that he is planning on putting 25-30 RVs on the lot where the old car wash was. He explained he purchased the lot and has cleaned it up. He explained he owns a RV park in Los Lunas and explained that the city would get Lodgers taxes from this RV park.

Commissioner Henderson asked if there would be long term parking.

Mr. Baca explained there will be that he has contractors that come in a rent the ones in Los Lunas for 6 months.

Mr. Henderson talked about his concern for the long term. He explained that when people come and park for years, they tend to accumulate a lot of stuff.

Mr. Baca explained that there will be a property manager on site.

Commissioner Winters asked about fences around the property.

Mr. Baca stated that he is working on putting a half million dollars on the property and explained that he has already had people reaching out for booking during the ballon fiestas.

Michal Johnson gave a presentation on the Mavrick site development. He explained that this site is on the Southeast corner of Highway 47 and Manzano Express Way. He stated that Maverick has built 800 stores in 20 states. He continued with his presentation and explained the lighting and landscaping on the site. He stated they use local themes in the store, and they will employee about 20 employees and explained the benefits that they offer to the employees.

Chair Good asked hoe you would exit to go South.

Mr. Johnson explained that you would exit on Manzano Express way to go south.

Commissioner Henderson asked if there would be fuel.

Mr. Johnson stated that there would be fuel just like any other Maverick. He stated that it will not be a site for semi-trucks
